**PHYSICIAN'S ORDER AND PARENT PERMISSION FOR
PRESCRIPTION AND NON-PRESCRIPTION MEDICATION
FOR SCHOOL YEAR 2023-2024 ONLY**

PHYSICIAN AND PARENTS: The purpose of administering medications at school is to assist students who require medication during school hours to maintain an optimal state of health and, therefore, enhance their educational program.

MEDICATIONS SHALL BE ADMINISTERED ONLY WHEN THE STUDENT'S HEALTH REQUIRES THAT THEY BE GIVEN DURING SCHOOL HOURS. NO MEDICINE WILL BE TRANSPORTED ON BUSES WITHOUT A PHYSICIAN'S ORDER TO SELF CARRY AND CLEARANCE FROM THE CAMPUS NURSE. ALL MEDICATIONS NOT PICKED UP BY THE LAST DAY OF SCHOOL WILL BE DISCARDED. NO MEDICATIONS WILL BE KEPT OVER THE SUMMER. Medications that are administered at school must be in properly labeled prescription or original over-the-counter packaging with the dosing instructions/guidelines. Over-the-counter medications to be kept for more than 10 school days require a physician's order. ALL medications (Rx and OTC) require this medication form signed by the parent. ****ASK YOUR PHARMACIST TO GIVE YOU TWO LABELED BOTTLES, ONE FOR HOME AND ONE FOR SCHOOL****
